DOGS ELIGIBLE TO ENTER

- On Monday, this trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.
- On Tuesday, this trial is open to all Belgian Tervuren SIX (6) months of age or older that are registered with the American Kennel Club.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

HANDLING MORE THAN ONE DOG

Per Chapter 2: Owners/Handlers and their Responsibilities: Section 10. **Handling More Than One Dog**. Handlers **may not** handle more than one dog in each class (with the exception of Handler Discrimination classes). Multiple dogs from the same owner may be entered in the same class, provided they are run by different handlers.

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an offleash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

A warm-up area the club shall designate a warm-up area. One labeled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class. **Search Area Conditions**. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

Search Area Sizes will be as required in the Regulations for AKC Scent Work.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area. Spectators are encouraged. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide.

Crating will be in the parking lot out of your vehicle.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

HIGH IN TRIAL

Only teams who participate in the same difficulty level in all elements offered (Container, Interior, Exterior, Buried) and qualify in each are eligible to win **High In Trial**. One High In Trial winner is chosen per difficulty level; there is no separate High In Trial for the Novice A and Novice B sections. The High In Trial is determined by adding the team's faults across the elements. If there is a tie based on faults, then the team's times across the elements will be summed and the faster-finishing team will win. The High In Trial award is not recorded by the AKC. Teams winning High In Trial will earn rosette.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Belgian Tervuren Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Belgian Tervuren Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Belgian Tervuren Club or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email.

Exhibitors MUST check-in EACH day they are entered.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.

POLICY ON STANDARD OF BEHAVIOR BY ABTC MEMBERS ATTENDING SPECIALTIES

With a commendable track record, the ABTC has consistently upheld the condition of Specialty show sites. We expect rings, grooming areas, and hotel rooms, which our members occupy, to be left undamaged and in a state of utmost cleanliness after the specialty show. As a matter of policy, the club has established the following standards of behavior to ensure this expectation is met

- 1. Dogs should not be left uncrated in a hotel room at any time in the absence of the room occupants.
- 2. Dogs that constitute a nuisance to other hotel occupants by continual barking or howling may subject their owners to removal by the hotel.
- 3. There will be no grooming of dogs in the hotel rooms. Grooming will be permitted only in the areas set aside for that purpose.
- 4. No dogs should be washed in hotel bathtubs, and hotel towels should not be used on dogs for drying them or any other purpose
- 5. The hotel and show site's external and internal premises shall be free of debris and feces caused by dogs attending the Specialty. 6. The Club will provide a committee to inspect rooms upon member checkout, separately from or in concert with designated hotel staff members. Should any room or its contents exhibit signs of unusual wear or damage because of the presence of a dog or dogs, the occupant of that room may be held up to censure by the Club and shall reimburse the hotel for all damages. Offenders may be censured, held in suspension of membership, or expelled from membership in the ABTC should the circumstances warrant. These consequences underscore the importance of adhering to the set standards.
- 7. While the ABTC cannot legally assume responsibility for the actions of individuals at its national specialties, it does hold an ethical responsibility for their conduct. The club is committed to ensuring that any individual who causes damage to the hotel or show site makes appropriate restitution.
- 8. The ABTC strongly advises its members to thoroughly inspect their rooms before checking out. This proactive measure can help prevent disputes over damages and ensure a smooth departure.

MEMBERS OF THE ABTC AND NON-MEMBERS ARE EXPECTED TO ADHERE TO THESE STANDARDS

THE ABTC 2025 NATIONAL SPECIALTY COMMITTEE MANDATES THE FOLLOWING RULES ON BEHALF OF YELLOWSTONE DOG SPORTS:

All exhibitors are required to maintain a clean grooming area throughout the event. Loose hair must be picked up, and any grooming products spilled on the floor must be cleaned. Grooming areas are provided in pristine condition, and exhibitors are expected to leave them in the same state. Each person is responsible for the cleanliness of their grooming space during the event and upon departure.

All children under 12 must be supervised. They are not to have free run of the facility at any time.

The indoor turf is NOT a designated exercise or play area for off-leash dogs. Any unauthorized use of the indoor turf will result in a \$500 fine.

To protect the agility turf, only chairs with feet that have plastic or rubber bottoms are permitted. Chairs with hard or exposed metal feet are not allowed. The Show Committee will ask exhibitors with unsuitable chairs to substitute them.

Shoes must be clean and dry before stepping on the turf. You should bring separate "turf" shoes from those you wear outside. NO FOOD OR DRINKS ALLOWED ON TURF (except water).

DO NOT throw bait. Anyone throwing bait is subject and may be excused with no refund and subject to bench committee action.

Do not bring litters of puppies to the show site.

All dogs must always be on leash unless in a pre-approved off-leash area or as needed for judging.

Non-ABTC members attending the 2025 National Specialty will adhere to the rules.

Grooming tents are NOT provided

No space for unentered dogs

There is no admission fee for spectators. However, spectators are asked to leave their pets home, as unentered dogs are not allowed on the show grounds.

THE CLUB reserves the right to substitute a prize of equal or greater value. All trophies must be claimed on the day of the show – none will be mailed.

Exhibitors are responsible for cleaning up after their dog(s). If the Event Committee deems an exhibitor to violate this requirement, the exhibitor may be excused without a refund. Cleaning supplies and disposal sites will be available at various showground locations.

The Show Committee will provide designated seating to accommodate individuals with accessibility needs

ALL EXHIBITORS are asked to remove all dogs and items from the show site facilities immediately upon the completion of BOB judging on Saturday, June 7, 2025.

NO DOGS will be allowed to remain in YDS facilities overnight.

CRATING & GROOMING: Grooming and crating in designated areas only. Crating space inside the arena may not be available for all entered exhibitors. The trial committee may assign crating spots. The bathing of dogs is limited to bathing in the designated area.
